

### THE CLASS OF 2010

#### PROFILE FROM THE OFFICE OF THE REGISTRAR

The Office of the Registrar reports the following demographic information regarding the Class of 2010. It is included to provide a useful background for other data contained in this report.

- Between December 2009 and August 2010, 1,656 degrees and certificates were awarded to 1,594 individuals.
- Baccalaureate degrees were awarded to 1259 graduates. A total of 1271 baccalaureate degrees were awarded as follows: 954 Bachelor of Science; 147 Bachelor of Arts; 47 Bachelor of Social Work; 92 Bachelor of Science in Nursing; 10 Bachelor of General Studies; and 18 Bachelor of Science in Engineering.
- Among the graduates, 94 percent identified themselves as white, non-Hispanic; 5 percent of the graduates classified themselves as minorities; and .9 percent did not specify.
- Among the graduates, 67 percent were female, the same as in 2009.
- 53 percent of the graduates were from Gibson, Posey, Vanderburgh, or Warrick counties, while 16 percent of degree recipients were from other area counties. Graduates from all other counties in Indiana represented 17.5 percent of the graduating class; 12.8 percent of the degree recipients were from other states; and .6 percent were from other countries .1 unknown.
- Baccalaureate degrees were awarded by the College of Liberal Arts (27.6 percent); College of Business (24.6 percent); Bower-Suhrheinrich College of Education and Human Services (17 percent); College of Nursing and Health Professions (22 percent); Pott College of Science and Engineering (8 percent); and Extended Services (.8 percent).

### EXECUTIVE SUMMARY / FOLLOW-UP SURVEY

This report is a six-month follow-up of the 2009-2010 graduating class; responses were received from 51.4 percent of the graduates.

#### **EMPLOYMENT RATES**

- 74.4 percent of respondents are employed; 79.7 percent of employed respondents are full-time, 20.3 percent of employed respondents are part-time. 26.9 percent of employed respondents are still seeking; 54.1 of those still seeking are full-time, 45.9 of those still seeking are part-time.
- There were only 62 unemployed bachelor graduates not working and not enrolled in additional coursework or attending graduate school that were actively seeking employment (7.56 percent of the total respondents).
- 64.8 percent of unemployed respondents are either enrolled in additional academic coursework or have chosen not to seek employment at this time. 34.7 percent of unemployed respondents are actively seeking employment 23.9 percent of respondents are unemployed.

- Of the graduates who are employed, 58.7 percent have secured new positions with a new employer, 15.3 percent have secured new positions with the same employer and 26 percent are employed in the same position they held prior to graduation.
- Among bachelor degree recipients who are employed, 88.9 percent are working "in their field or in a field in which they expressed satisfaction", a slight decrease from 89.5 percent in 2009. (Education majors employed as substitute teachers are coded as working "in their field".) Among ALL graduates employed, 89.8 percent are working in their field of study (2009 figure = 91.5 percent).
- Among bachelor degree recipients who are employed, the number of underemployed bachelor graduates is 18.47 percent.

### CONTINUED EDUCATION

- Among bachelor degree recipients who completed the questionnaire, 17.4 percent were attending graduate school within a year of graduation, up 1.3 percent from 2009 (16.1 percent).
- Among associate degree recipients, 41.3 percent are currently completing requirements for a baccalaureate degree, down 2.2 percent from 2009 (43.5 percent).
- Among bachelor degree recipients, 5.9 percent are enrolled in additional undergraduate coursework. This is a decline of 1 percent from 2009.

### **GEOGRAPHIC LOCATION**

- Among all employed graduates, 71.5 percent accepted employment within the tri-state (a 60mile radius of the University), an increase of 4.8 percent from 2009 (66.7 percent). Thirty-eight of these individuals reside in Kentucky or Illinois.
  - 27.9 percent of the employed bachelor degree recipients left the tri-state area in 2010, a 4.8 percent decrease from 2009 (32.7 percent).
  - 39.8 percent of the employed master degree recipients left the tri-state area in 2010, an increase of .1 percent from 2009 (39.7 percent).
  - 26 percent of the employed associate degree recipients left the tri-state in 2010, a 1.3 percent decrease from 2009 (27.3 percent).
- Among all 2010 graduates, 16.32 percent left the tri-state to accept employment elsewhere in Indiana (18.5 percent in 2009), bringing the total number of 2010 graduates who work and utilize services in Indiana to 87.8 percent. When the 38 Illinois and Kentucky residents are subtracted from the tri-state figure, the state retention rate for 2010 employed USI graduates is 81.4 percent, a 1 percent increase from 2009.

#### SALARY STATISTICS

- The average starting salary for baccalaureate degree graduates securing NEW, FULL-TIME POSITIONS was \$34,364, a .03 percent increase over the average starting salary of \$34,269 in 2009.
- The average starting salary for associate degree graduates securing NEW, FULL-TIME POSITIONS was \$45,921 an increase of 27.4 percent from the average starting salary of \$36,049 in 2009.
