I Approval of the Minutes (Glassman)

There were no new minutes for approval.

II Portfolios (Glassman)

There were a few minor corrections to the handout for the junior faculties' portfolios. It was decided that the previous Chair, Dean, and Evaluation Committee letters should be included in the portfolio. It was suggested that the handout become an appendix to and be referenced in the Greenbook.

III Orientation Advising Fellows (Palladino)

The Dean asked the Chairs to see if they could find additional faculty to become Orientation Advising Fellows.

IV Anti-plagiarism Software (Raymond)

It was suggested that our College purchasing anti-plagiarism software. The University has had software in the past but it has not been well publicized. Angela Torres is to research the possible options that are currently available.

V Banner Policy Decisions (Glassman)

The Dean is to meet with the other Deans and the Provost on Friday to discuss the Banner policies.

Question 1 (Course repeats) - The consensus is that the change presented is reasonable.

Question 2 (Pre-registration priority) – The consensus is that we currently have too many students that are allowed to pre-register. Some felt that student workers should not be allowed to pre-register unless they are required to work in their area during certain set hours.

Question 3 (Maximum hours for probation students) – The Dean is to check on the flexibility of the Chairs and Deans to override the 13 hour maximum.

Question 4 (Academic standing updates) – It was agreed that the Incomplete stay on the permanent record and that the GPA be retroactively adjusted for the grade in the course.

Question 5 (conditionally admitted students) – It was understood that a student is on probation due to poor performance and their admission to the university should be conditional.

Question on removing holds – It as agreed that holds should be removed by the Chairs, the AAs, or the Deans' offices.
