# I. New Course/Course Modification Petitions

ENG 226. S. Spencer introduced the petition for the new course ENG 226: Introduction to Folklore. Some questions were asked about the proposal to petition this course as an elective within the World Languages and Cultures category of the Core 39, as it appears to focus on American folklore. The petition was approved unanimously.

JRN 273. W. Rinks introduced the petition to modify the pre-requisites for JRN 273: Digital Photography. The petition was approved unanimously.
