# Liberal Arts Council February 25, 2014

## I. Approval of Minutes

The minutes of January 28, February 4, and February 11, 2014 were approved unanimously.

#### **II. New Course Petitions**

ART 255. J. deJong introduced the petition for ART 255: Introduction to African Arts. The petition was approved unanimously.

INST185. C. Rivera introduced the petition for INST185: Introduction to Africa. T. Schroer asked how much overlap there was with this proposed course and ANTH 326 and ANTH353. C. Rivera explained that there would be some overlap, but that these courses would complement each other. The petition was approved unanimously.

Bordelon reported that he has received a list of software that the College of Liberal Arts currently uses and that he does not know what departments use some of the software for which we currently pay a subscription fee. The cost of software has become an increasing concern as some companies have moved their software to the cloud, and annual fees must be paid for its use. He requested the names of individuals from each department to work with him to identify the software needs for each department. He will work also with R. Toeniskoetter to determine whether or not the University can purchase any of it. C. York will distribute to chairs the list of software that the College of Liberal Arts currently purchases.

## VI. Assessment in the College of Liberal Arts

M. Aakhus reported that the College of Liberal Arts must make some modifications to the proposed Strategic Plan, specifically the components related to assessment. He noted that we must develop improved methods by which to communicate the data we collect to OPRA. He will invite both Kat Draughn and Dane Partridge to a future meeting so that we can discuss strategies by which we can transfer our data to their offices. S. Spencer asked questions regarding the program review process, and its role in assessment; others echoed his concerns with the lack of feedback that departments have received.
