THE CLASS OF 1995 / GENERAL STATISTICS

The Office of the Registrar reports the following salient findings regarding the Class of 1995. Awareness of these general features may enhance your understanding of other data contained in this report.

- 899 degrees and certificates were awarded to 892 individuals between December 1994 and August 1995.
- Baccalaureate degrees were awarded to 667 graduates of which 520 were bachelor of science degrees, 68 were bachelor of arts, 28 were bachelor of social work, 50 were bachelor of science in nursing and 1 received a bachelor degree in occupational and general studies.
- 30.7% of the graduates were 30 years of age or older.
- 96.8% of the graduates identified themselves as white, non-Hispanic ethnic origin. 2.1% of the graduates classified themselves as minorities and 1% as non-resident aliens.
- Over 6 of every 10 graduates (65%) were female.
- 63.7% of the degrees were received by graduates from Gibson, Posey, Vanderburgh and Warrick Counties. 14.9% of degree recipients were from other area counties. Graduates from all other Indiana counties represented 9.9% of the graduating class; 10.5% of the degree recipients were from other states; 1% were from other countries.
- The School of Nursing and Health Professions awarded almost three-fifths (59.6%) of the associate degrees and the School of Business awarded over a fourth (26.9%).
- 31.9% of the baccalaureate degrees were awarded by the School of Liberal Arts, followed by the School of Business (25.2%), the School of Education and Human Services (22.6%), the School of Nursing and Health Professions (12%), and the School of Science and Engineering Technology (8.3%).

EXECUTIVE SUMMARY

This report is a six-month follow-up of the 1995 graduating class; responses were received from 69.4% of the graduates.

EMPLOYMENT RATES

- 94.2% of the respondents are actually in the job market. Of the remaining 5.8%, 7 persons are unemployed by choice. The remainder are pursuing additional degrees.
- 69.6% of the graduates have secured new positions as a result of their degree; 23.5% are employed in the same position that they held prior to graduation. 10 individuals did not indicate the status of their employment. The remaining 4.4% are unemployed.
- Among bachelor's degree recipients who are in the job market, 84.8% are employed "in their field" (up from 83.9% in 1994). Among ALL graduates, 87.6% of those in the job market are employed in their field of study. (The decision was made to classify education majors who are employed as substitute teachers as graduates working "in the field".)
- 10.7% are underemployed (i.e. working in a field unrelated to their career goals.) This figure was 13.2% one year ago.
- 4.4% of the bachelor's degree recipients are unemployed and looking for work, compared to 3.0% in 1994. Among all graduates, the unemployment rate is 3.6%.

CONTINUED EDUCATION

- 11.5% of the bachelor's degree recipients who completed the questionnaire were attending or planned to attend graduate school within a year of graduation. This figure was 10.9% in 1994 and 13.4% in 1993. A detailed listing of graduate/professional school attendance appears on pp. 26-28.
- 47.7% of the associate degree recipients are currently completing requirements for a baccalaureate degree.
- 7.3% of the bachelor's degree recipients are enrolled in additional undergraduate classes, an increase over the 6.6% recorded in 1994 and significantly higher than the 1.7% reported in 1991.

GEOGRAPHICAL LOCATION

- 85.8% of the graduates accepted employment in the tri-state, down from 87.2% in 1994.

JOB SEARCH STRATEGIES

- 31.3% of all working graduates report that they remained employed with the same firm they were working for prior to graduation (master's degree recipients = 52.8%; bachelor's degree recipients = 24%; associate degree recipients = 50%).
- Of the remaining 68.7%, 23.4% secured positions through direct application to the employer; 25.2% through the University (including Career Services, a faculty member or as a result of an internship or co-op assignment); 23.9% through family or friends; 17.7% from a classified ad; and 2% through an employment agency. The remaining 9.6% did not provide this information.

SALARY STATISTICS

- The average starting salary for baccalaureate degree graduates securing a NEW position was \$22,695, a 3.8% increase over the average starting salary of \$21,860 in 1994.
- Associate degree recipients averaged \$23,530, up 1% from last year's average of \$23,304.
- Salary information regarding Master's degree recipients may be found on pp v-vi.

CAREER SERVICES & PLACEMENT USAGE

- 50% of bachelor's degree recipients registered with Career Services for graduate placement assistance. 27% requested help with resumes or interviewing strategies, 30% have used the Career Resource Center, 21% have registered with the Job Locator (part-time job) Service and 20% have sought career or job counseling.
- 18% have participated in internships or cooperative education through the Career Services Office. Graduates from the School of Liberal Arts are most likely to take advantage of these opportunities; 35% of survey recipients from Liberal Arts indicate participation in an internship.
- 74% of the bachelor's degree recipients have utilized the Career Services Office at some time during their tenure at USI. Usage is highest among students from the School of Business (86%), followed by the School of Liberal Arts (82%), the School of Education and Human Services (73%) and the School of Science and Engineering Technology (68%).
- 29% of Master's degree candidates and 40% of associate degree recipients utilize Career Services programs.

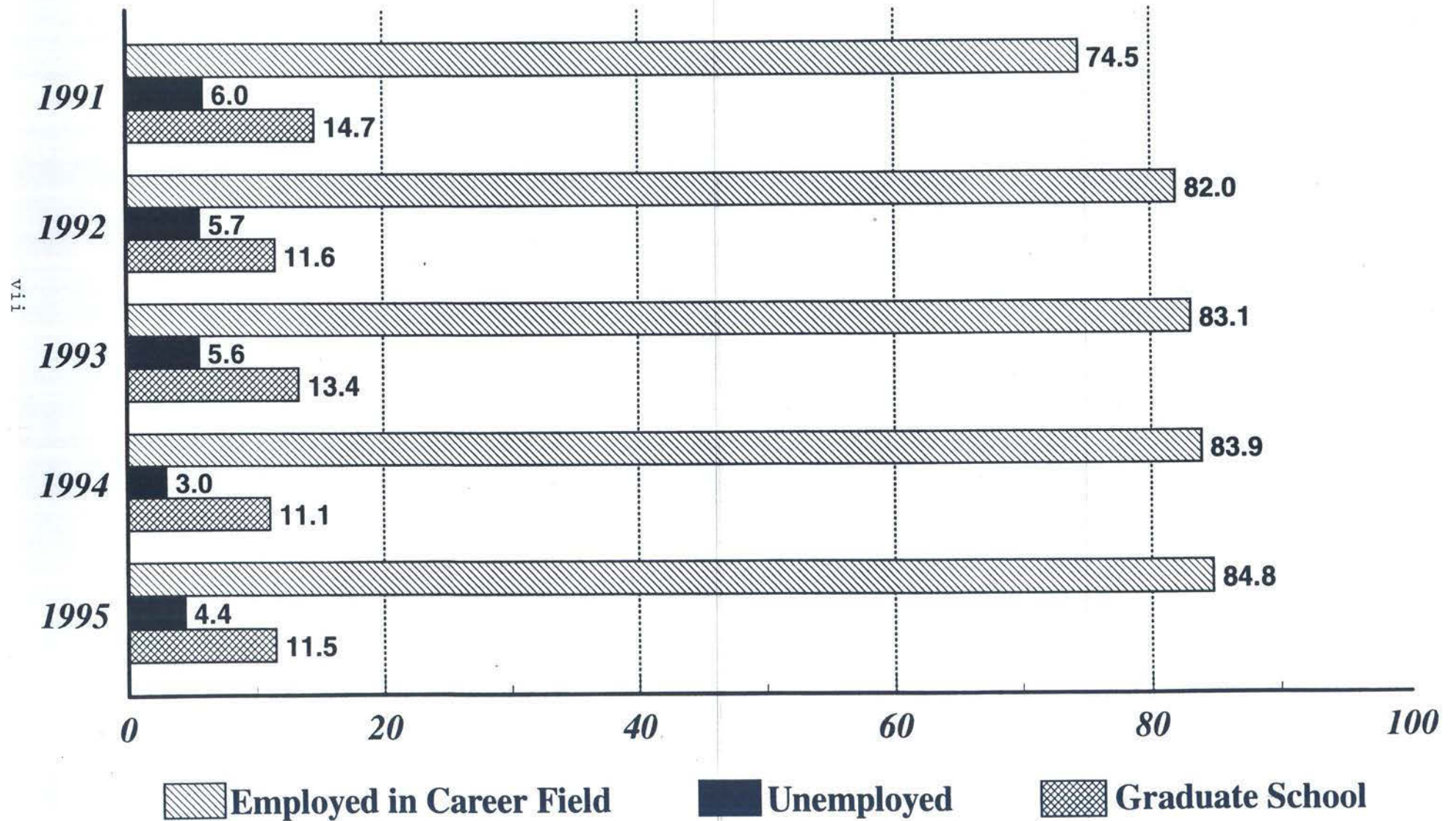
