

USI Dental Clinic Sets Veteran Days for Spring 2018

The University of Southern Indiana Dental Hygiene Clinic will provide free dental cleaning, fluoride and X-rays for military veterans from March 12-15. 2018. This is the first time this program has been offered for this many days.

"There is an increasing demand for dental care in the veteran community and we have increased these dates in an effort to meet that demand" said Joel Matherly, Assistant Director of the USI Veteran Military and Family Resource Center.

This schedule includes morning, afternoon and evening hours to serve more veterans.

"In the past, these dental cleaning appointments have booked very quickly," said Matherly. "The huge response points to the need in our community for veterans to have



access to this type of care. We appreciate how the USI Dental Hygiene Clinic has responded to the veterans."

The USI Dental Hygiene Program collaborates with SouthwestIndiana Area Health Education Center (SWI-AHEC) and USI's Veteran, Military and Family Resource Center to offer the special clinic hours for veterans. USI Dental Hygiene faculty will supervise the students who will be working in the clinic.

Appointments are required and can be made by calling 812-464-1706. Proof of military affiliation and a picture identification is required.

The USI Dental Hygiene Clinic is located on the USI campus in the Health Professions Center Room 1040.

REMINDER: Applicable Fees for VA Consideration for Ch 33

When you are on Chapter 33, Post 9/11 benefits, one of the items that can be paid are fees. However, not all fees qualify to VA coverage.

In order for fees to qualify, they must meet one of three (3) criteria:

- 1. Must be class related
- 2. Must be required for graduation
- 3. Must apply to all students without the possibility of refund

The semester fees that appear on students bills that fall under that criteria include lab fees assigned to any class, University Services, Enrollment, Application, Transportation and Parking, Distance Education and Nursing Pinning.

Student Activities Fee will not be paid by the VA. The Student Activities Fee (\$50) is placed on every account until the student requests a refund. Because this is a refundable fee, it can not be billed toward the VA.

As USI enrollment grows, the cost of providing student programs and activities also increases. The new student activity fee assures that present programs and services can continue and that significant new programs and services can be introduced.

To apply for a refund on the Student Activities fee, you can request this on-line at: https://www.usi.edu/deanofstudents/ student-activity-fee.

Once you request a refund, it will be removed from your bill from that point until you reinstate it. This request must be made at the start of the semester.

If you receive a debt letter from the VA as a result of an over paid fee, you will need to follow the instructions on the letter.

YOUR DD214 - WHAT is It and WHY is It Important

When you were discharged from the Active Component, you were furnished a DD214 Discharge Certificate. Of all the documents you have presented to you, no one is more important than your DD214.

This single piece of evidence is all that exists when you leave the service and is the only document most entities, like the Department of Veterans Affairs, will accept to enroll you in their programs.

We are often amazed at how many of our students are unaware of not only what this document is, but also its importance and role.



Recently, we assisted a Veteran family with a request for a service members records after their Veteran was found to have cancer. Not only could this Veteran not receive VA care, but he also could not receive funeral honors that was afforded to him for his years of service simply because he nor his family could produce his DD214.

If your Drill Sergeant never told you, we are telling you now. Guard this document the best way you can. This includes natural disasters, theft and fire. To do this, the Vanderburgh County Recorders Office will file your DD214 for FREE.

As the official repository for Veteran Discharge Documents, the County Recorder's office has

a unique ability to preserve one of the most valued possessions of your membership, separation documents. The Chief Deputy Debbie Stucki, of the Vanderburgh County Recorder 's Office would like to encourage you to record your discharge papers. Again, it is a free service.

The documents are restricted and available only to appropriately accredited personnel.

Often times, it is forgotten that certified copies of this paperwork plays a role in key benefits such as burial rights.

As an added incentive to record DD214s, their office has also created

another free service for our Veterans known as Honor Rewards. Veterans can participate by recording their documents and signing up for the program at www.honorrewards.com.

They will issue an Honor Rewards Identification card. This card qualifies you for discounts and incentives at participating businesses in our community. To date, in 2017 we had 50 veterans sign up for an Honors Reward Card. We currently have 25 businesses offering a discount.

Military Discharge Upgrade Tool Now Available Online - By James Oxford, Legislative Commission chairman



Veterans with other than honorable (OTH) discharges – also known as "bad paper" discharges – do not qualify for VA benefits

and services. However, it is clear that many OTH discharges can be attributed to undiagnosed post-traumatic stress disorder or traumatic brain injury symptoms. Congress instructed the Department of Defense (DoD) to create a process through which these discharges can be appealed and, possibly, reversed.

Through a joint initiative, DoD and VA launched an online tool (www.vets. gov/discharge-upgrade-instructions) to help veterans with the discharge recharacterization process.

The site will ask veterans a few questions. By answering them, the veteran will know which board they need to go to, what form to fill out, any special guidance applicable to their case, where to send their application, and helpful tips for appealing their discharge.

President signs bill easing CDL rules for active-duty troops, reservists

On Jan. 8, President Trump signed into law **Public Law 115-105**, the Jobs for Our Heroes Act, which clarifies eligibility rules for active-duty servicemembers and reservists applying for commercial driver's licenses (CDLs) under U.S. Department of Transportation programs.

Previously, lawmakers had created a special program for veterans seeking CDLs, which allowed them to skip driving tests and some certification requirements if they had previous applicable experience from their time in the military. But those provisions did not include reservists who have not yet separated from the military or active-duty troops planning ahead for their post-service careers. Transportation officials created a two-year exemption to cover those groups, but the new legislation makes those changes permanent.

In addition, the new law also allows more VA medical professionals to perform required federal health examinations for the licensing processes. Because of current rules, only a small number of VA staffers meet the requirements for administering those tests.

President issues executive order addressing veteran suicide

On Jan. 9, Trump signed an executive order that instructed the DoD, VA and Department of Homeland Security (DHS) to develop a joint plan addressing veterans suicide, especially in the first year after leaving military service. The departments have 60 days to develop a plan and must report on its implementation and effectiveness within 180 days of the signing date.

The order specifies that the plan should work to streamline access to mental health services throughout an individual's transition to civilian life and across the DoD and VA. The inclusion of the DHS means that the Coast Guard will be covered by

VFW Offers a Stage for Student Veterans - By Dave Spiva

As part its commitment. to education and legislative activism, VFW collaborates

with Student Veterans America (SVA) to provide 10 student veterans a fellowship opportunity each year. THe VFW-SVA Legislative Fellowship is a semesterlong academic experience that involves research, action, reporting and advocating for veterans' policies.

Karthik Venkatraj was one of the 10 fellows selected for the third fellowship class in 2016. He enlisted in the Army National Guard in 2007 and is currently service asa Captain. In 2015, he was a targeting officer with the Colorado National Guard attached to 3rd Sqdn, 6th Cav 1st Armored Division in support of Operation Inherent Resolve

in Iraq.

As a VFW-SVA fellow, Venkatraj, a memeber of VFW Post 1 in Denver, met with lawmakers to discuss issues regarding the VA. Venkatraj also became the first fellow to have his proposal become law. His plan will provide highly qualified candidates from the public and private sectors for the VA's top management positions. The proposal was given to the House Committee aon Veteran Affairs and latter added to a bill with was pasased by congress and signed into law in August 2017.

Venkatraj said he is glad to be a part of the fellowship because it makes him a part of VFW's "legacy".

"People take the time to listen and understand our proposals because we are a part of the

VFW," Venkatraj said. "VFW has an incrediable connection to legislators that is unparalleled. That is whu I jopind the VFW in the first place. It is a wellrespected organization foll of men and women whom I look up to."

Venkatraj would said he encourage other student veterans to applu for the VFW-SVA fellowship.

"I was the first to propose a polict that became law, and I know that I won't be the last," he said. "I want our success to continue through the other fellows."

Venkatraj completed law school in 2017 at the University of Colorado Boulder, in CO. After graduation, he moved to Washington D.C. and plans to work in the federal law enforcement community.

QUESTIONS TO THE VMFRC - Student Q&A Passed to You!

Are VA Education Benefits Taxable?

No. Any veterans' benefits paid under any law administered by the Department of Veterans Affairs (VA) should not be reported as income to the Internal Revenue Service (IRS). You will not receive a W-2 from the VA.

Per IRS Publication 970:

"Payments you receive for education, training, or subsistence under any law administered by the Department of Veterans Affairs (VA) are tax free. Do not include these payments as income on your federal tax return.

If you qualify for one or more of the education benefits discussed in chapters 2 through 13*, you may have to reduce the amount of education expenses qualifying for a specific benefit by part or all of your VA payments. This applies only to the part of your VA payments that is required to be used for education expenses.

Example.

You have returned to college and are receiving two education benefits under the latest GI Bill:

1.a \$1,534 monthly basic housing allowance (BAH) that is directly deposited to your checking account, and \$3,840 paid directly to your college for tuition.

Neither of these benefits is taxable and you do not report them on your tax return. You also want to claim an American opportunity credit on your return. You paid \$5,000 in qualified education expenses (explained in detail in (explained in detail here in IRS publication 970, chapter 2). To figure the amount of credit, you must first subtract the \$3,840 from your qualified education expenses because this payment under the GI Bill was

required to be used for education expenses. You do not subtract any amount of the BAH because it was paid to you and its use was not restricted."

How is my housing allowance paid if I'm not a full-time student?

Under the Post-9/11 GI Bill, a Veteran enrolled at more than one-half time can qualify for a monthly housing allowance based on DoD's Basic Allowance for Housing (BAH) rate for an E-5 with dependents. VA determines eligibility for housing allowance by calculating the rate of pursuit. Rate of pursuit is expressed in a percentage calculated by dividing the number of credits in which the student is enrolled by the number of credits considered to be full time. A student with a rate of pursuit greater than 50% can qualify for the housing allowance.

Undergraduate

For undergraduate enrollments, 12 semester or quarter hours are generally required for full-time training. The school submits the term dates and credit hours of the enrollment to VA and we calculate the rate of pursuit.

For example, if 12 credits is considered full-time, a course load of 6 credits yields a rate of pursuit of 50% (6 ÷ 12 = .50), whereas a course load of 7 credits yields a rate of pursuit of 58% (7 ÷ 12 = .58). In this scenario, a Veteran would need to enroll for at least 7 credits (such as two 3-credit classes and a 1-credit lab) in order to receive the housing allowance benefits.

Some schools offer classes in terms that are shorter than a standard length semester or quarter. This is especially true for online classes and summer enrollments, but some schools offer accelerated terms at brick-and-mortar campuses year round. In these cases, VA calculates weighted "equivalent credit hours" so that fewer credits are required for full-time (and more than half-time) training.

Graduate

Because graduate level programs vary in the amount of credits required for full-time training, the school provides the training time information to VA in addition to the term dates and credit hours of the enrollment.

Monthly Housing Allowance Payments

Once the training time is determined, the monthly housing allowance is paid at the nearest 10% level. For instance if your training time is determined to be 58% as calculated above you will be paid 60% of the applicable housing allowance. If your training time is calculated to be 84% you will be paid 80% of the applicable housing allowance.
