- Existing searches should not be affected by expedited search.

- Current practice: President has right to waive search. This would allow Provost to use this and target goals.
- BL: Getting faculty buy-in gives the candidate a little more leeway and help, as opposed to no faculty participation.
- What role would search committee or department faculty have in saying whether there should be expedited search? Initiated from chair. PC: Would like to see some language that chair has at least discussed it with faculty.
- Motion to endorse proposal with amendments passed with one objection. Amendments: Third paragraph: "Requests for waiver *should* be initiated by a department chair or head and must be recommended by the dean and/or division directed" be changed to *must* and that language be introduced to include "in consultation with the faculty". Provost Rochon asked HR to come back in a year to update on this new policy.
