# Priority Registration Begins for VA Students November 4 at Noon

If you are a VA Education Benefit recipient, you qualify for priority registration for Fall 2019.

This will begin on **Monday**, **November 4**, **2019 at noon** and is available to students based on the number of earned and attempted hours.

Students given permission to register early through group affiliation will be able to sign up for classes via myUSI beginning on at noon. This will not be available until that time.

Because your time with VA benefits is limited, this ensures you get your classes unless you have additional holds at that time.

# Understanding Your 'Veteran Hold' Administrative - Protection Ensures VA Compliance

If you have tried to drop or add a course, you may have been told that your account has a "Veterans Hold" and wondered what exactly is this?

### Why is this important?

Part of your responsibility as a VA Education beneficiary is to keep our office informed of any changes to program or classes – either drop or add. In the past, we found a majority of our students were dropping, adding classes or changing their program (Major) without informing our office which causes an under payment or debt to the student.

Another issue is when students mobilize or feel they are getting ready to mobilize. This hold ensures they are coming through our office so they can out process from the University and offices (such as Financial Assistance, Bursar, Registrar and Advisor) completely to ensure a smooth transition back when they decide to return.

To combat this, we have placed holds on our student Veteran accounts so that you come to us and inform our office of the changes you need to make.

It is not our intent to prevent any change; it is only a means to keep your account with the VA current and to advise you of any payment changes as a result.

We want you to be informed at all times. This is the same type of hold our University uses with its athletes.

#### Will this effect my Priority Registration?

This hold will not affect your priority registration. This hold will be placed each semester on the Monday after the 100% drop/ add period (typically the first full week of class) and extend until the Friday before Priority Registration begins.

### Can I have it removed if I don't want it?

In an effort to keep or your individual account and the university in compliance, this administrative hold must be in place if you are receiving educational benefits under the Department of Veteran Affairs.

If you need your hold temporarily removed to perform maintenance on your account, please contact our office during business hours and it will be lifted temporarily.

The University of Southern Indiana Dental Hygiene Clinic will provide free dental cleaning, fluoride and X-rays for military veterans on November 4-8.

The USI Dental Hygiene Program has expanded its schedule to include morning, afternoon and evening hours to serve more veterans.

"In the past, these dental cleaning appointments have booked very quickly," said Joel Matherly, manager of the Veteran, Military and Family Resource Center at USI. "The huge response points to the need in our community for veterans to have access to this type of care. We appreciate how the USI Dental Hygiene Clinic has responded to the veterans."

The USI Dental Hygiene Program collaborates with Southwest Indiana Area Health Education Center (SWI-AHEC) and USI's Veteran, Military and Family Resource Center to offer the special clinic hours for veterans. USI Dental Hygiene faculty will supervise the students who will be working in the clinic.

Veterans Groups Release Statement on the Higher Education Reautorization Act (HEA)- By Ryan Raback, Student Veterans of America, media@studentveterans.org

Today, Chairman Alexander's statement to pursue a piecemeal approach to a reauthorized Higher Education Act (HEA) is a disappointing departure from the comprehensive negotiations many military and veteran serving organizations have repeatedly asked for on HEA reauthorization. Our disappointment is compounded by his statements ignoring our long-standing, repeated requests to close the 90-10 loophole.

Closing the 90-10 loophole must be included in any HEA efforts, a priority shared in a letter earlier this year signed by 37 organizations. Ignoring such a long-standing and widely supported request to close the 90-10 loophole and bring parity to student protections for military-connected students hurts service members, veterans, and their families. Not closing the 90-10 loophole is a dealbreaker for military and veteran serving organizations.

While we appreciate Chairman Alexander communicating a willingness to continue conversations surrounding HEA, we hope he will indeed work across the aisle to develop a bipartisan, comprehensive HEA that puts the needs and interests of students at the center of policy. We have made continued efforts to meet with Chairman Alexander and his staff to work collaboratively on this process and hope those requests are accepted soon.

VA Launchpad for Veterans is a new mobile app that simplifies and organizes several existing tools and resources into one convenient location to help manage health care needs.

"VA has developed dozens of apps for Veterans to take charge of their health care," said VA Secretary Robert Wilkie. "VA Launchpad makes it easier to have these important tools available at your fingertips." Download VA Launchpad

VA Launchpad arranges all of VA's apps into five categories for Veterans: health management, health care team communication, vital health information sharing, mental health improvement, and quality of life improvement. Some of the apps include:

The new app enables Veterans to access all the features with a single secure login.

The mobile app also includes many mental health care and personal improvement tools for individuals who are not enrolled in VA health care services. These tools are free and do not require secure logins to use.

VA Launchpad for Veterans is available for download in the Apple App Store and Google Play. To access VA's secure apps within VA Launchpad, users must be a VA patient and have one of the following accounts: Premium My HealtheVet, DS Logon Level 2 (Premium) or ID.me.

# Your Benefits Now - New 6-16 Rule to Effect Transferability of Chapter 33 Benefits Questions and Answers from the VA

On March 8, 2019, the VA announced chages to Chapter 33 / Post 9/11 benefits that effect the service requirements to transfer your benefits to your dependents.

The new 6 to 16 year rule contained in the latest OUSD (P&R) Post 9/11 GI Bill program guidance, DoDI 1341.13 (published on 12 Jul 2018), will go into effect on 12 July 2019.

# How does the 6-16 Rule effect me if I am still serving?

When implemented, Soldiers must have at least 6 years but not more than 16 years of total creditable military service (active duty and/ or Selected Reserve service) to be eligible to transfer Post 9/11 GI Bill education benefits to their TEB eligible dependents.

A Soldier's total years of creditable military service is calculated based on the date of the transfer request, not the date the transfer request was processed. Additionally, submission of a transfer request within the new eligibility parameters does not guarantee approval. Soldiers are highly encouraged to submit a transfer request via milconnect as soon as they reach six creditable years of military service - do not wait! The earlier eligible Soldiers submit and receive approval for TEB, the earlier they will start fulfilling the TEB four-year additional duty service obligation.

# Can I be exempt from this rule?

Soldiers who have received a Purple Heart on/after 11 September 2001 are exempt from the 6 to 16 year rule and may submit a transfer request regardless of their total years of creditable service.

# How do I prove I transferred benefits in time?

Once you complete the transfer request on milconnect, you are highly encouraged to print off the confirmation page which also shows the date.

You will need to retain this printout for your records.

The biggest issue we see in the office is when service members believe they transferred benefits prior to their ETS, but there is no record and no proof that a transfer ever occured.

# Chapter 33 - Post 9/11 - How do I transfer my benefits to my dependents?

## Can I transfer benefits?

You can transfer benefits if you're on active duty or in the Selected Reserve and you meet the requirements listed below.

At least one of these must be true:

1. You have completed at least 6 years of service on the date your request is approved and you agree to add 4 more years of service, or

2. You have completed at least 10 years of service on the date your request is approved, can't commit to add 4 more years of service because of either a policy or statute, but agree to serve for the maximum amount of time allowed

3. And this must also be true:

The person getting benefits has enrolled in the Defense Enrollment Eligibility Reporting System (DEERS).

## What benefits can my qualified dependents get?

If the DoD approves the Transfer of Entitlement (TOE), your spouse or dependent children can apply for up to 36 months of benefits, and may be able to get money for: Tuition Housing Books and supplies

#### How do I transfer the benefit?

While you're still on active duty, you'll request to transfer, change, or revoke a Transfer of Entitlement (TOE) through milConnect.
