I. English (O. Popescu-Sandu)

O. Popescu-Sandu proposed revising the minor programs listed below in order to create more emphasis on their respective concentrations. Additionally, the minors will be reduced to 18 credit hours to be more aligned with other Liberal Arts minors. Finally, several courses had their course descriptions updated.

Dean Beeby asked O. Popescu-Sandu if these changes involved the creation of new classes, to which O. Popescu-Sandu answered there were no new classes. S. Rode moved to approve the above proposed changes, A. McKibban seconded the motion, and all members approved.

II. Criminal Justice (T. Schroer)

T. Schroer proposed editing the pre-requisites for the courses below in order to make the curriculum more streamlined. The previous pre-requisites were also outdated. Additionally, CRIM 302 will have CRIM 204 and POLS 208 as pre-requisites to help other minors. O. Armeanu stated that the elimination of POLS 208 and SOC would not be good for students in terms of exposure.

S. Rode moved to approve, and W. Durham seconded the motion. The motion was passed with the abstention of O. Armeanu and A. Buck.

III. Global Studies (S. Gupta)

- S. Gupta proposed modifying the GLST major and minor by adding ENG 319 (Fundamentals of Grant Writing) to the program curriculum as an elective. Grant writing has become a crucial skill for Global Studies. Dean Beeby asked if ENG 319 would be offered often to which S. Gupta confirmed it would be.

IV. Performing Arts (E. Wasserman)

E. Wasserman proposed creating a new course, THTR 207 (Play Analysis), which is a standard course for many theatre programs. L. A. Howard asked why other alternative courses, such as Dramatic Literature Analysis, were not used instead of creating a new course. E. Wasserman explained that, from his experience of teaching that course, enrollment tends to be an issue. He would also like to provide earlier exposure to the subject, giving a broader view to a diverse selection of plays.
